TYPE OF DATA PROCESSED AND PROCESSING PURPOSE

Data provided voluntarily by the User.

Personal data provided by users through communications sent to the e-mail addresses and/or through the information request forms present on the website, including requests for sending informative material (brochures, catalogues, etc.), and requests for downloading DECA proprietary programs and utilities, will be used for the sole purpose of responding to the communications and/or requests received.

Browsing data.

Information systems and software procedures used for the functioning of this website acquire, during their normal operation, certain personal data of users whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified Data Subjects, but which by its very nature could, through processing and association with Data held by third parties, allow users to be identified.

This category of Data includes IP addresses or domain names of the computers used by Users who connect to the website, the addresses in Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (success, error, etc.) and other parameters related to the user's operating system and computer environment.

This Data is only used to obtain anonymous statistical information on the use of the website and to check its correct functioning and is deleted after processing.

The Data in question could be used to ascertain responsibility in the event of any cyber-crimes against our website.

Cookies.

No personal data of users is acquired by the website in this regard.

We do not use cookies to transmit information of a personal nature, nor are so-called persistent cookies of any kind or user tracking systems used.

The use of so-called session cookies (which are not stored permanently on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) necessary to allow safe and efficient browsing of the website.

The session cookies used on this website avoid recourse to other technologies that could compromise the user browsing privacy and do not allow the acquisition of the user's personal identification data.

OPTIONAL NATURE OF DATA PROVISION

Without prejudice to that specified for browsing Data and cookies, the user may decide whether or not to provide personal Data to request information and/or services. Failure to provide such data may make it impossible to receive that requested.

PLACE OF DATA PROCESSING AND PERSONS THAT ACCESS DATA

Our website is hosted at the provider Register.it belonging to the Dada group. Processing related to the web services offered is carried out at our offices in Segrate, Via Galilei 2, by employees or collaborators who have been expressly authorised to for processing and have received appropriate operating instructions.

No data is communicated or disseminated, unless such communication is imposed by legal obligations or by judicial authorities.

PROCESSING METHODS

Personal Data is processed with automated tools, only for the time necessary to achieve the purposes for which it was collected. Specific security measures are observed to prevent Data loss, illicit or incorrect uses and unauthorised access.

RIGHTS OF THE DATA SUBJECT AND COMPLAINTS TO THE SUPERVISORY AUTHORITY

By contacting DECA via e-mail at info@deca.com, data subjects may request access to the Data concerning them, its deletion, the correction of inaccurate Data, the integration of incomplete Data, the deletion of Data, restriction of processing in the cases provided for by Art. 18 of the GDPR and object to the processing carried out based on the legitimate interest of the controller.

Furthermore, if the processing is based on consent or on a contract and is carried out using automated tools, data subjects have the right to receive the Data in a structured, commonly used and automatically readable format, as well as, if technically feasible, to transmit it to another controller without impediments.

Data subjects have the right to lodge a complaint with the competent Supervisory Authority in the Member State in which they normally reside or work or in the State where the alleged violation occurred.

Data subjects have the right to revoke the consent given at any time for marketing purposes and to object to the processing of Data processed for said purposes. This without prejudice to the possibility for data subjects who prefer to be contacted for the aforementioned purpose exclusively through traditional methods to express their objection only to receiving communications through automated methods.
